I will be using the Remind101 App to send messages throughout the season. Instructions on how to sign up are enclosed. Please join so you will stay up to date on all region news. If you were a member last year you should already be signed up. Also, please follow us on Facebook at Tri-State Region 1 Rodeo.

We will be starting to do Entries online this year through Equest Event. You will have to create an account on their website, where you will enter for each rodeo. There will be dates set for each rodeo for when the books open and the books close. You will pay with a credit card for your entries. There will be a convenience fee that you will pay for each rodeo. More information on that process will be coming soon.

At Perryton, you will need to check-in to get your back numbers and raffle tickets. You will also turn in your Fundraising check when you pick up your back number and raffle tickets. This check will need to be postdated to December 1, 2022. It will not be cashed until that date. This gives you plenty of time to sell your fundraising items.

The following items need to be completed in the NHSRA Portal at www.nhsra.com.

Returning members use the same log in information from last year. If you can't remember your password, click forgot password.

If you are new member, you must create an account.

If you are a returning HS member(including 8th graders moving up) you <u>do not</u> have to upload your birth certificate, w9, or the Photo Release form again.

You will pay your membership fees (\$300 plus a \$20.25 processing fee) online with a credit card: \$124 National, \$121 State, \$55 Region 1.



GUIDELINES FOR RENEWING MEMBERSHIPS/NEW MEMBERS

RENEWING MEMBERSHIPS:

If a renewing member has any questions regarding renewing their membership, please be advised that there is a demo video on the login screen (see below). Please be advised that ALL Active, Returning, Renewing NHSRA members ALREADY have an account setup. PLEASE ADVISE YOUR MEMBERS NOT TO CREATE A NEW ACCOUNT. [See below for reference on the login screen]



If a renewing member, District Secretary and/or State Secretary creates a new account for an existing member, it will be deleted and the member will have to go into their existing account to complete their registration. In addition, any documents uploaded into the new account will have to be uploaded into the existing account by the member.

As secretaries, you have access to all your members' profiles, which contains their usernames and email addresses.

Below are instructions on how members access their profiles, see below:

- If a member does not know their username, they can click "Forgot Username?" to receive an email providing this information or they can contact you to obtain their username.
- If a member does not know their password, they can click "Forgot Password?" to receive an email with a link to reset their password.


• Please be advised that if a member clicks "Forgot Username?" and/or "Forgot Password?" and does not receive an email, it is probably because the email address on their profile is not current. If this is the case, you will have to edit their profile to correct their email address in order for them to receive the email with their username and/or password reset link.

If you or the member cannot find their existing profile, their status may be inactive or deleted. Our office will have to restore their profile before you or the member are able to access it. NHSRA Membership Application:

The NHSRA Membership Application must be signed by the member, natural father, natural mother, <u>or</u> legal guardian. If only one parent is signing the form, they must note the reason on the signature line – refer to page 6 for acceptable and unacceptable terminology.

NHSRA Membership Application Checklist:

- Verify the membership application is for the current season.
- ✓ Verify that the application uploaded to the member's profile is the member's paperwork and not a sibling, etc.
- ✓ Verify State/District/Region is correct.
- ✓ Verify grade and rookie status are correct.
- ✓ Verify that the member, natural father, natural mother, or the legal guardian have all signed the application.
- ✓ Signatures must be handwritten-NHSRA does not accept electronic signatures.

Minor's Release:

The minor's release must be signed by the member, natural father, natural mother, <u>or</u> legal guardian before a notary public. Once again, if only one parent is signing the form, they must note the reason on the signature line - refer to page 6 for acceptable terminology.

Both mother and father MUST be listed as having appeared before the notary. Paperwork will be sent back as incomplete if only one parent is shown as having appeared so that it may be corrected. The same applies if no one is listed as having appeared before the notary. In some cases, a notary will refuse to notarize the signature of a minor who does not possess a form of legal identification. Should this be the case, the parents should ask the notary to have this notated on the release. Regardless, the minor is still required to sign the release whether it be in front of the notary or not.

Minor's Release Checklist:

- ✓ Verify the NHSRA Minor's Release is a current computer-generated release and is not an outdated or incorrect release.
- ✓ Verify the minor's release uploaded into the profile is the members release and not a sibling, etc.
- ✓ Verify the member, natural father, natural mother, or legal guardian have all signed the paperwork.
- ✓ Verify the date the release was notarized to ensure it was signed for the current season and not from a past season.
- ✓ Verify both parents appeared before the notary when signing the release.
- ✓ Verify for signature, date, and stamp/seal and expiration date of the notary.
- ✓ Verify that the notary was not a parent, as notaries are not allowed to notarize their own signature.

Acceptable/Unacceptable Signature Terminology:

Below is a list of acceptable and unacceptable terms used when parents sign paperwork.

Acceptable Terminology:

- ✓ Deceased
- ✓ Full Custody
- ✓ Sole Custody
- √ Sole guardian/guardianship
- ✓ No father is listed on the birth certificate in this case the birth certificate must be uploaded to the profile.
- ✓ Permanent protective order (only if it pertains to the member)
- ✓ POA (Power of Attorney)

Unacceptable Terminology:

- · Full or sole physical custody physical custody is not legal custody
- Primary custody being a primary parent does not exclude the other parent from having legal rights.
- Primary parent
- Divorced
- Separated
- No custodial rights
- Court-ordered custody or "see court order"
- Lives with mother and/or father, not available, and/or NA
- Out of state

Circumstantial Scenarios:

- Military/Deployed personnel Typically, the other parent has a POA and/or affidavit allowing him/her to act on behalf of their spouse during deployment
- Incarceration
- · Traumatic brain injury
- · Eye disease and/or blindness
- · Any disabling reason

These scenarios will be reviewed on a case-by-case basis given the circumstances. It is highly preferred that parents in these scenarios sign the paperwork accordingly. It will ultimately be the decision of the Executive Director if the information provided meets the requirements and more information may need to be provided to make a final decision.

Transfer Request Form:

The transfer request form is now handled by the NHSRA. Forms are sent to the National Directors for an e-signature via Adobe Sign.

- The form will be sent to the Home-State National Director first. Once signed, the form will then
 be automatically sent by Adobe Sign to the Transfer-State National Director. Following that
 signature, the form will, then again, be automatically sent to the NHSRA office for the Executive
 Director's approval.
- The NHSRA office will upload the completed transfer request form directly into the members profile and approve the transfer as well as confirm a new and/or updated membership number has been issued.
- Upon approval, the member will receive a notification email as well as the National Directors and State Secretaries.

Change in procedure for entry forms

Everyone will need to fill out the following "Contestant Approval Form" and submit it with or prior to our first entry form.

You will no longer have to get "EACH" entry form signed by the principle or notarized; however, you MUST take this form to your school and have it signed by your superintendent or principle. You will also need to take this form to have it notarized. This form will stand good for your seasons entry forms as long as this form is on file with the secretary. **Entry forms will not be accepted without it on file.** You, your parents or guardians will also have to sign before submitting to secretary.

<u>PARENTS</u>: You will need to check the "X" box for all events that you are allowing your contestant to compete in as well as initial and date this box. If contestant enters an event that has **NOT** been checked by parent approval the computer <u>WILL NOT</u> accept the entry. Therefore, if you are considering entering other events at a later date (such as cutting) then you need to check and approve those events as well.

MEMBERSHIP REQUIREMENTS

Welcome prospective members to the National and Texas High School Rodeo Association. We are pleased to know that you are thinking about becoming a member in this great association where "The Elite Compete". Along with the requirements of the region you are thinking about joining, there are a few the THSRA requires, and so there will be no misunderstanding as to what these requirements are, they are listed below:

- 1. You must be in good standing, under 20 years of age, and be considered a full-time student with passing grades in 70% of classes taken. Any student attending a **private**, **homeschool**, **year-round school or correspondence school**, must show proof of full-time status (passing 70% of classes) and the grade report must be a professional, computer generated document with the signatures of the teacher(s) for each subject. Any of these types of schools must be a state accredited school/program. If there are any questions, you must get pre-approved **ONE (1) MONTH PRIOR TO DEADLINES** through the THSRA State Office by calling **936-590-4447**. All students, even the ones in public school, will be required to turn in a report card or transcript with their membership application, at mid-term and at the State Finals. Any questionable documents of public, private, home, year-round or correspondence school received at deadline times will result in ineligibility of points for a minimum of two (2) rodeos, until the problem is worked out. **Any documents that are falsified will result in immediate disqualification from the association**.
- 2. You will be required to sell **fifteen (15) Truck Raffle tickets** by December 2022 and have these returned to your region secretary. For every five (5) tickets sold, you will receive one (1) free ticket.
- 3. You will required to sell three (3) \$50 Bloomer Trailer Raffle ticket by December 2022 and have this returned to your region secretary.
- 4. You will also be required to sell at least **one (1) \$50 State Ad** for the THSRA State Finals program. For any additional ads sold, the member will receive 25% commission on the additional ad amount and your region will receive 20% commission once the total sales has reached \$350.00.

THSRA members selling the most total ads and sponsorships will receive the following awards:

1st place - Trophy saddle (must have a minimum of \$3,000 in ad sales)


HIGH SCHOOL RODEO INFO FOR REGION 1 2022-2023

- ↓ Memberships must be COMPLETED on the NHSRA website at least two weeks prior to the rodeo you want to compete in. For the first rodeo, memberships need to be completed by August 15th, 2022. There will be a \$25 late fee for memberships processed after August 15th.
- This year you will enter online through equestevent.com. You will need to create an account on the website. Pay attention to the dates that the books open and close. You will pay your entry fees with a credit card. I will be updating you with instructions on how to sign-up and enter as soon as I get them. The books for Perryton/Gruver will open on August 15, 2022.
- ♣ Entries will be posted on Monday afternoon/evening of rodeo week on our website under the Results tab if not before. It is your responsibility to make sure you are entered in the correct events. If not, call ASAP.
- Draw-Outs must be received by noon, the Monday of rodeo week for fees to be refunded.
- Medical or Vet draw outs will be honored only if I am notified two hours before the rodeo starts. I will need a vet release if draw out involves your horse. If your horse is injured during the rodeo, you must send me a vet release by the following Monday from your vet to receive a refund.
- ↓ High School offers slack to its members. Slack will be run off on Sunday mornings at 8:00. The cost is \$150. If there is more than one person in a family that needs slack, the cost is \$100 per person after the first one. If someone wants slack in the team roping and their partner agrees to move to Sunday morning they do not have to pay the slack fee unless they decide to move their other events to Sunday morning as well. Slack will not be offered at the Perryton/Gruver rodeos.
- High School offers a jackpot run in the team roping. If you choose to have a jackpot team roping run, you must declare which one is a state run and which one is the jackpot run. You may not rope with the same person on both runs unless you switch ends.
